

To: Rock Springs City Council & Urban Renewal Agency

We, the undersigned business owners and stakeholders along North Front Street, respectfully request reconsideration of the recently approved layout for the Downtown Main Street Market relocation.

We support the continued success of the Main Street Market and recognize its value to the community. However, the current approved plan, which closes both:

- The parking strip along North Front Street, and
- The adjacent diagonal parking spaces

creates significant and unnecessary impacts.

Our Concerns

1. Excessive Parking Loss

Closing both areas removes approximately half of the available on-street parking in the affected block for the entire day on Thursdays. For brick-and-mortar businesses operating weekly and year-round, this represents a material burden.

2. Disproportionate Impact on a High-Traffic Corridor

North Front Street carries substantially more vehicle traffic than Main Street. It is a primary route through downtown. Eliminating large portions of parking along an active traffic corridor creates operational strain not present at prior market locations.

3. Safety Risks

Maintaining through-traffic while placing food trucks and vendors along the curb increases pedestrian crossings in a higher-speed, higher-volume traffic environment. This configuration may increase risk to pedestrians, vendors, and motorists.

Requested Modification

We respectfully request that the layout be adjusted to:

- Utilize the **entire length of the parking strip only (near the tracks)**
- Keep the **diagonal parking spaces open and available**

This modification would:

- Preserve critical customer parking

- Reduce economic impact to local businesses
- Improve safety conditions
- Maintain sufficient space for the market to operate successfully

This request represents a reasonable compromise that supports both community events and area businesses.

We ask the Council and URA to reconsider the configuration prior to implementation.
